Both the libraries are of higher educational purpose and so they believe that collaboration and on operation between themselves will promote more effective use of each of their library resources and provide with each of them with enhanced opportunities.

PURPOSE & SCOPE OF THE MOU

The purpose is to obtain, upon request of a library's primary clientele; materials or copies not available in the library may be shared or borrowed. Both the libraries under the agreement must be willing to lend library resources per request of the other one.

GENERAL POLICIES:

1. Only books and other items available on the premises of each library may be used for ILL transactions.
2. Books which cannot be lend may be photocopied and used.
3. Each participating library should keep records of the number of requests sent and received.
4. Loan periods should be adequate to allow for transmission in both directions as well as use by the borrower.

RESPONSIBILITIES OF BORROWING LIBRARIES

1. The borrowing library must record name and contact details of the end user.
2. The borrowing library shall ensure that are returned on time and respect any special conditions imposed.
3. If damage or loss occurs, the borrowing library must meet all cost of repair or replacement.
4. If the publication is out of print or otherwise not available in the market. The concerned user has to pay [3] times more than the purchase price/ current price of publication whichever is higher.


RESPONSIBILITIES OF LENDING LIBRARIES:


1. When making a loan, clearly state the applicable conditions of the loan.

VALIDITY:



10. Arbitration

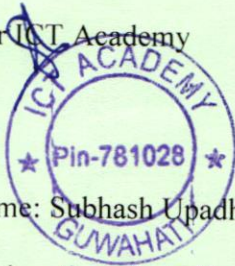





4. Seminar/Special Lecture/Workshop may be jointly organized by faculty members of Department of Political Science of both the colleges.





5. **To organize extension education programmes** : To organize extension education programmes in collaborating mode for the benefits of students.
6. **To utilise the library resources** : To utilise the library resources of both the college by students and teachers.
7. **The students will be made to comply with the rules of both the institutions.**
8. **Arrange special lectures** : Arrange special lectures jointly by scholars of national and international repute on annual basis.
9. **To make every effort to support and promote long term teaching research linkages between the two institutions.**

Operational Aspects :

The terms of such mutual cooperation and necessary budget for each specific programme and activity that is implimented under the terms of this MoU shall be mutually discussed and agreed upon in writing by both parties prior to the particular programme or activity and the terms of such programmes shall be negotiated wherever required.

Scope of Cooperation :

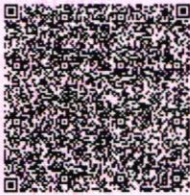

Knowledge Resource Centre, Salbari College, Salbari represented by Dr. Jagat Ch. Basumatary, Principal of Salbari College
And
District Library, Mushalpur, Baksa represented by Jinti Das, Librarian for Inter Library Loan, Knowledge and Resource Sharing

Whereas:

Both the libraries are of educational purpose and so they believe that collaboration and on operation between themselves will promote more effective use of each of their library resources and provide with each of them with enhanced opportunities.

PURPOSE & SCOPE OF THE MOU:

The purpose is to obtain, upon request of a library's primary clientele; materials or copies not available in the library may be shared or borrowed. Both the libraries under the agreement must be willing to lend library resources per request of the other one.

GENERAL POLICIES:

1. Only books and other items available on the premises of each library may be used for ILL transactions.
2. Books which cannot be lend may be photocopied and used.
3. Each participating library should keep records of the number of requests sent and received.
4. Loan periods should be adequate to allow for transmission in both directions as well as use by the borrower.

RESPONSIBILITIES OF BORROWING LIBRARIES:

1. The borrowing library must record name and contact details of the end user.
2. The borrowing library shall ensure that are returned on time and respect any special conditions imposed.
3. If damage or loss occurs, the borrowing library must meet all cost of repair or replacement.
4. If the publication is out of print or otherwise not available in the market. The concerned user has to pay [3] times more than the purchase price/ current price of publication whichever is higher.

RESPONSIBILITIES OF LENDING LIBRARIES:

1. When making a loan, clearly state the applicable conditions of the loan.
2. Ensure that items supplied on loan are clearly marked with name and address of the owning library, the date by which the loan is to be returned.
3. Send timely courtesy reminders and or overdue notices for the items that are due to be returned.
4. Keep statistics on the number of items requested and the number of requests filled.

VALIDITY:

We, Knowledge Resource Centre, Salbari College and District Library, Mushalpur, Baksa agree to this agreement by approving the above item policies of the Inter Library Loan for Libraries. This agreement will be valid from to 29/11/2023 to 29/11/2024 for one year until it is deliberately terminated by either party on mutual agreed terms, during which period will take effective for steps for implementation of this MOU.
